Senator Mike Moon's SB 49 https://senate.mo.gov/23info/pdf-bill/perf/SB49.pdf, The SAFE Act to prevent our Missouri's most vulnerable children from being mutilated by the transgender Medical Industrial Complex (Washington University) is another example of one man circumventing the will of the people. Plocher will not put it on the House calendar.

Representative Bill Hardwick 's SINGLE ITEM bill regarding Protecting Missouri's school children from a school district demanding that they have the UNTESTED MRNA injections in order to attend school is an example of good legislation being stopped by bad leadership. We call this a Christmas Tree bill, and it is ornament season! Is this what you call good leadership? Good legislation? Do you know why this is happening? Because the lobbyists are in control. The lobbyists, mainly big Pharma with big money in the medical community, make huge donations to campaigns, the campaigns that they think will be in leadership with promises, probably of more money to come. To whet the appetite of those power-hungry legislators? To advance their political career. Therefore, honest and true legislators that go to Jefferson City to represent the needs and wishes of the impotent, the rights of Missouri citizens are never heard. Because the lobbyists make sure that who they want is in leadership and the votes of those that they need on committees are also heard, but not those truly representing the people!

Look at all the grasping last week. all these bills were tacked on as amendments to ONE BILL because Plocher/Patterson Leadership refused to allow them to be heard on the House of Representatives floor.

LEGISLATIVE PROCEEDINGS

Section 21. Style of laws—bills—limitation on amendments—power of each house to originate and amend bills—reading of bills.—The style of the laws of this state shall be: "Be it exacted by the General Assembly of the State of Missouri, as follows." No law shall be passed except by bill, and no bill shall be so amended in its passage through either house as to change its original purpose. Bills may originate in
